## A. LIABILITY RELEASE AND HOLD HARMLESS AND INDEMNIFICATION

AGREEMENT. I hereby release the Iowa Organization of Walleye Anglers which is organized and operated by Walleye Promotions, LLC, and its officers, directors, agents or employees, and sponsors (herein referred to as I.O.W.A., et al) from all negligence, damages, claims, demands, costs or fees relating to injury to any person or property which I or any passenger may sustain and which is caused by any negligence, foreseen or unforeseen and which may be attributed to I.O.W.A.'s, et al's negligence, Acts or omissions, and which is related to my participation in this activity. Further I hold harmless and Indemnify I.O.W.A., et al, for any acts which may be attributable in part or in whole to my actions or negligence and where any other person or passenger suffers any type of damage whatsoever. I agree to hold harmless I.O.W.A. et al, for any attorney's fees they incur in defense of my acts and omissions and negligence. I understand that by participating in this tournament that I may cause or sustain injury including but not limited to: loss of life, loss of limbs, electrocution, paralysis, coma, loss of mental functions, loss of sight, loss of speech/smell, dehydration, exposure, hypothermia, frostbite, sun stroke and all other injuries that may be caused in a boating accident and/or exposure to the elements. I further release and indemnify I.O.W.A., et al for all damages relating to adverse weather conditions while participating in this tournament. It is my responsibility to seek safety should adverse and/or unforeseen weather conditions occur prior to, during or after the tournament. I agree that any litigation between myself and I.O.W.A. et al will be heard in the Iowa Dist. Ct. for Wright County, Iowa applying Iowa laws.

B. COVENANT NOT TO SUE & WAIVER OF SUBROGATION. I agree that I will not sue I.O.W.A., et al for damages on account of any negligence causing injury, death or damage I suffer or cause whether known now or which may develop in the future. In the event a claim is made against I.O.W.A., et al on account of my negligence, actions or omissions, I expressly agree to indemnify and hold I.O.W.A. et al harmless from any liability whatsoever, including court costs and attorney's fee, arising with respect to such actions. I understand that in waiving my rights to sue I.O.W.A., et al I am also waiving the rights of recovery from I.O.W.A., et al of my insurance carrier for any claims they may pay on my behalf.

C. VERIFICATION OF LIABILITY INSURANCE. I maintain a minimum of \$100,000 liability insurance on the boat I will use in this activity. Insurance policy must state that the insurance covers the boat and any liability of the owner or operator.

D. POLYGRAPH/VOICE STRESS TEST Failure to take or pass the polygraph/voice stress examination when asked to will result in disqualification without recourse.

E. I am responsible for my fish and I will maintain them in my possession until they have been given to the weigh master for weighing at each event.

F. I SIGNIFY by my signature that I have read all tournament rules and this liability release and agree to abide by all rules, regulations, releases and tournament official's decisions. I agree that this release is binding for all I.O.W.A. events in which I may participate including the championship invitational.

Those that pay for all 4 qualifiers by January 15 will have top priority of entry. After that, order of received entry will determine who will be entered into a specific event. Order of received entry will determine the take off order for the first qualifier. Entries will be accepted beginning January 1, 2010. Any entry received prior to January 1, will be processed after those entries received January 1.

The order of take-off in the remainder of the events is determined by "Team of the Year" standings.

o May 23 - West/East Okoboji -\$50 late fee begins May 17

o Oct 1,2,3 Invitational State Championship - Rathbun, IA \$250 Entry (Invitation Only)
